Report on the Audit of the Standalone Financial Statements

Opinion

We have audited the financial statements of Jai Balaji Energy (Purulia) Limited ("the Company"), which comprise the balance sheet as at 31st March 2023, and the statement of Profit and Loss and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Act in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at 31st March, 2023, its loss and its cash flows for the year ended on that date.

Significant Accounting Policies & Notes to Financial Statements for the year ended March 31, 2023

1. Significant Accounting Policies

a. Basis of Preparation of financial statements

- d. <u>Earnings per share</u> Basic earnings per share is calculated by dividing the net profit or loss for the year attributable to equity shareholders by the weighted average number of shares outstanding during the year.
